



COVID 19 Assumption of Risk/Waiver of Liability

In consideration of being allowed to participate on behalf of NFYFC/NFYCC and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS NFYFC/NFYCC, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law. FOR PARTICIPANTS OF MINORITY AGE (UNDER AGE 18 AT THE TIME OF REGISTRATION)

This is to certify that I, as parent/guardian, with legal responsibility for this participant, have read and explained the provisions in this waiver/release to my child/ward including the risks of presence and participation and his/her personal responsibilities for adhering to the rules and regulations for protection against communicable diseases. Furthermore, my child/ward understands and accepts these risks and responsibilities. Sportsmanship Zero Tolerance Policy

As the parent or guardian of a NFYFC/NFYCC sports team player, I agree that the most important outcome of any game is for my child to have fun. My child needs my approval and support, regardless of what happens in the game. I will refrain from the use of negative or derogatory language aimed at the Officials, the Coaches, NFYFC/NFYCC staff, my child, or other players. I will encourage my child and all others in the game and will let the coach be the coach. I will do my best to model the sportsmanship-like behavior I wish my child to adopt, and to support the coach in making this the best possible experience for my child. I further agree that I will be responsible for all guests/spectators that I bring to any sanctioned event. If any member of my party is officially removed from any sanctioned event, regardless of if by game official or association board member, I and my player are subject to a dismissal of 1 week, or more, depending upon severity of expulsion. I further agree and acknowledge that I signed the Participant Registration form for the NFYFC/NFYCC and will abide by all items contained within.
